ACF	ALIAS CAPIAS ON FORFEITURE OF BOND	Warrant issued for defendant who was originally arrested, made bond, then failed to appear for court date.
ACS	ALIAS CAPIAS ON SURRENDER OF BOND	Bondsman no longer wishes to hold bond; therefore, he/she either takes defendant into custody or has a warrant issued for arrest.
ACW	ALIAS CAPIAS	Warrant re-issued on a capias pro fine, worthless check warrant or traffic warrant. This code is used only by justice of the peace courts.
AC2	ALIAS CAPIAS 2	Second warrant re-issued on a capias pro fine, worthless check warrant or traffic warrant. This code is used only by justice of the peace courts.
AC3	ALIAS CAPIAS 3	Third warrant re-issued on a capias pro fine, worthless check warrant or traffic warrant. This code is used only by justice of the peace courts.
AJW	ALIAS JUSTICE COURT WARRANT	Second issue of a warrant by a justice of the peace court.
ATT	ATTACHMENT	Warrant issued when witness does not appear when subpoenaed.
BCH	BENCH WARRANT	Warrant issued for defendant who is in custody in another jurisdiction but who needs to appear in a Harris County court as a witness or defendant.
BFW	BOND FORFEITURE WARRANT	Warrant issued by justice of the peace when a defendant fails to appear for court date. This code is used only by justice of the peace courts.

CAP	CAPIAS	Warrant for arrest. May be signed by clerk. Also, in justice of the peace courts only, indicates a bond forfeiture warrant.
CPF	CAPIAS PROFINE	Warrant for arrest due to nonpayment of court fines/costs.
CM	COMMITMENT	Warrant issued for defendant already in custody to permit retaining the person in custody.
CMW	COMMITMENT	Warrant issued for defendant already in custody to permit retaining the person in custody. This code is used only by justice of the peace courts.
COM	COMMITMENT ON CONTEMPT OF COURT	Warrant issued by judge to give time or fine to any person who fails to appear in court; exhibits offensive behavior in court; or is judged to be in contempt of court for any reason.
CPW	COMMITMENT	Warrant issued for defendant already in custody to permit retaining the person in custody. This code is used only by justice of the peace courts.
DCW	DISTRICT COURT	Warrant issued by justice of the peace courts for defendants who owe child support in state district family court. This code is used only by justice of the peace courts.
EXP	EXPARTE	Instrument required to allow fugitive to have hearing in district court where he/she may waive extradition {waive rights to have attorney and rights to protest being sent back to the state originally issuing warrant} if desired.
FUG	FUGITIVE WARRANT	Warrant issued by local authorities for fugitive {person wanted by another state} to allow agency to hold defendant pending notification and arrival of authorities from the state requesting that the defendant return for trial. Warrant is good for 90 days from date of issuance for arrest.



GOV	GOVERNOR'S WARRANT	Warrant issued by governors of each state involved in fugitive extradition proceedings if defendant refuses to waive extradition by protesting return to state that wishes to place him/her on trial and requests attorney assistance.
JCW	JUSTICE COURT WARRANT	Warrant issued by justice of the peace court.
MDT	ALIAS CAPIAS ON MANDATE	Warrant issued for defendant with case on appeal due to court of appeals issuing a mandate of affirmance on a defendant sentenced to serve time.
SMN	SUMMONS	Process service to organization {and occasionally a person} which does not require arrest. This is a legal notification.
TRF	TRAFFIC WARRANT	Warrant issued for arrest due to nonpayment of traffic fine.
TRW	TRAFFIC WARRANT	Warrant issued for arrest due to nonpayment of traffic fine. This code is used only by justice of the peace courts.
WAR	WARRANT	Warrant issued for arrest that must be signed by judge {capias may be signed by clerk}.
WCW	WORTHLESS CHECK WARRANT	Warrant issued for defendant who issued a bad check.
WHC	WRIT OF HABEAS CORPUS	Paper issued by defendant {or attorney} as relator requesting a lower bond or release due to belief that he/she is being held without cause. The writ may also be a request to file only one bond instead of the multiple bonds set for multiple offenses.
87A	COMMITMENT FROM COURT	Issued when defendant is in court and judge raises bond. If defendant cannot make bond, this warrant allows defendant to be retained in custody.

## Caution Text Indicator Codes (CIN Field on Various Screens)

<b>A</b>	<b>ASSAULTIVE/COMBATIVE</b>	Inmate has demonstrated violence and/or aggression toward staff, or has had a charge filed against him or her while in custody.
<b>C</b>	<b>CAUTION</b>	Previously used to indicate a general reference of caution. See LPER transaction for the individual's exact caution.
<b>E</b>	<b>ESCAPE</b>	Inmate has a current charge or conviction of escape or attempted escape or these types of charges appear on their criminal history. This does not apply for evading arrest charges or juveniles who did not report to the Texas Youth Commission authority.
<b>K</b>	<b>KEEP SEPARATE</b>	Inmate should be kept separate from another inmate. This will apply for all inmates known to have been charged with fighting each other while in custody, co-defendants, and close relatives such as siblings, and parents and children.
<b>L</b>	<b>LAW ENFORCEMENT</b>	Inmate is a police officer, former police officer, or an immediate family member of a police officer. This will also apply to correctional, parole and probation officers. In addition to immediate family members, other individuals related to law enforcement may be assigned this caution code if a supervisor determines it is necessary.
<b>P</b>	<b>PSYCHOLOGICAL</b>	Inmate is currently housed per authority of the Mental Health and Mental Retardation Authority (MHMRA), has a history of being housed as an MHMRA patient, or is currently being prescribed psychotropic medication.
<b>M</b>	<b>MEDICAL</b>	Inmate has a special medical handicap. This includes but is not limited to inmates who are blind or hearing impaired, inmates with medical conditions such as diabetes or tuberculosis, and inmates who require the assistance of prosthetic devices, wheel chairs, walkers, or canes. Inmates enrolled in substance abuse programs may also receive this medical caution.

<b>R</b>	<b>RESTRAINTS</b>	Inmate is combative or considered an escape risk and should be restrained. A sergeant, lieutenant, captain, etc., can recommend that an inmate be restrained. Factors such as current charge and criminal history will be taken into consideration.
<b>S</b>	<b>SUICIDAL</b>	Inmate has attempted suicide, exhibited suicidal tendencies or expressed thoughts of suicide.
<b>D</b>	<b>DISCIPLINARY</b>	Inmate has been charged with a violation of the Inmate Handbook or a state charge while in custody.
<b>I</b>	<b>INFORMATION</b>	Inmate has some other special character trait or situation. Character traits include but are not limited to homosexuality, gang affiliation, psychological referrals, etc. Situations may include transfers by medical from one facility to another that does not include a medical housing location.
<b>W</b>	<b>WORKER</b>	Indicates that the inmate is assigned to a trustee/worker position or that they have past trustee/work history.
<b>T</b>	<b>TRAINING</b>	Indicates that the inmate is enrolled in an educational program or a trade school training program.
<b>H</b>	<b>HOUSING</b>	Indicates that an inmate must be housed in administrative separation until a housing location becomes available.
